

PARTICIPANT'S CONTRACT & GENERAL INFORMATION

DOCUMENTS: A valid passport is required for Europe. (Passport must be valid 6 months beyond your return date).

BAGGAGE ALLOWANCE FOR SWISS: 2 checked bags; neither can weigh more than 50lbs., exceed 62 inches or 158 cm., total dimensions not to exceed 107 inches or 270 cm. One pair of skis, boots and poles are considered as one piece of baggage measuring 55 inches. **CHECK LUGGAGE RESTRICTIONS AND CHARGES WITH ALL AIRLINES ON YOUR FLIGHT ITINERARY.**

DEPOSIT AND PAYMENT: A non-refundable deposit of \$500 per person is required at time of booking. No reservation will be considered firm until the deposit and signed Reservation Application have been received. A second deposit of \$1200 per person is due September 1, 2010. Full and final payment is due 60 days before departure. All prices in this brochure reflect a 4% discount for purchases made by cash or check. There are **No Discounts** for sales made with credit cards.

CANCELLATION AND REFUNDS: Due to the nature of this trip, Penny Pitou Travel, Inc. reserves the right to impose the following cancellation penalties:

LAND ARRANGEMENTS: The \$500 non-refundable deposit will be forfeited if cancelled after initial booking. *(Cancellation must be in writing)*. If cancelled 60 - 30 days before travel, total tour prepayment will be forfeited unless the trip can be resold in which case an administrative fee of \$150 will be charged. Within 30 days - NO REFUND.

AIR TICKETS: Tickets are non-refundable.

CANCELLATION OF LAND ARRANGEMENTS WHILE ABROAD: No refund will be granted for any cancellation, alteration or shortening of itinerary. This applies to unused hotel, bus transportation and ski passes. **Once travel has commenced NO REFUND is permitted.**

CHANGES TO NAME OR ITINERARY: Any changes made to your itinerary or to the name of the passengers traveling after final payment has been made will be subject to a \$100 per person revision fee plus any penalties assessed by the airline or other suppliers.

ITEMS NOT INCLUDED: Airfare, insurance, lift tickets, lunches, beverages at dinner portorage at the airports and any items of a personal nature (passport, etc.)

CURRENCY EXCHANGE RATES: Due to the volatility of currency markets, Penny Pitou Travel reserves the right to adjust the final price on any tour based on the exchange rate at the time of final payment (60 days in advance of departure). All prices are based on currency rates in effect at the time of printing; however, if there is a significant change in the rates, your final trip price will be adjusted. Pricing for all tours is a combination of US dollars, Euros and Swiss Francs so the increase/decrease will not be a straight prorated amount.

INSURANCE IS STRONGLY RECOMMENDED. IT IS THE PARTICIPANT'S RESPONSIBILITY TO ENROLL IN THE INSURANCE PROGRAM. Details will be provided upon receipt of deposit.

IMPORTANT NOTICE: All land arrangements are based on a minimum of 30 people traveling together. Currency exchange rates and air fares are based on tariffs in effect as of March, 2010 and are subject to change without notice.
