

# PARTICIPANT'S CONTRACT, GENERAL INFORMATION AND TOUR CONDITIONS

**DOCUMENTS:** A valid passport is required for Europe. Passport must be valid 6 months beyond your return date.

**DEPOSIT AND PAYMENTS:** A non-refundable deposit of \$500 per person, per week is required at time of booking. No reservation will be considered firm until the deposit and signed Reservation Application have been received. A second deposit of \$1500 per person, per week is due September 1, 2022. Full and final payment is due 90 days before departure. All prices reflect a 5% discount for purchases made by check. There are NO DISCOUNTS for sales made with credit cards.

**CANCELLATION AND REFUNDS:** Due to the nature of this trip, Penny Pitou Travel, Inc. reserves the right to impose the following cancellation penalties: All payments are non-refundable unless the space is resold, in which case there is a \$500 pp administration fee. If cancelled within 90 days of travel, total tour prepayment will be forfeited.

**INSURANCE IS STRONGLY RECOMMENDED. IT IS THE PARTICIPANT'S RESPONSIBILITY TO ENROLL IN THE INSURANCE PROGRAM.** Details will be provided upon receipt of deposit. To cover preexisting conditions, insurance needs to be purchased within 14 days of initial deposit.

**NOT INCLUDED:** Airfare, trip cancellation insurance, lift tickets, lunches, beverages at dinner (coffee, tea, wine, etc.), items of a personal nature.

**CURRENCY EXCHANGE RATES:** Due to the volatility of currency markets, Penny Pitou Travel, Inc. reserves the right to adjust the final price on any tour based on the exchange rate at the time of final payment (90 days in advance of departure). All prices are based on currency rates in effect at the time of printing. However, if there is a significant change in the rates, your final trip price will be adjusted. Pricing for all tours is a combination of US dollars, Euros and Swiss Francs so the increase/decrease will not be a straight prorated amount.
