ACKNOWLEDGEMENT OF RISKS AND HAZARDS LIABILITY RELEASE AND COVENANT NOT TO SUE

1. I understand that alpine travel, mountain trips, hiking, biking, ski touring, alpine skiing, snowboarding and other travel or alpine activities are HAZARDOUS ACTIVITIES. I understand that hiking, biking and the use of various modes of travel, and alpine skiing, ski touring, snowboarding and the use of skis, snowboards, and other equipment and lifts, involves risk of injury to any and all parts of my body. I understand that there are numerous risks and dangers inherent in the sports of hiking, biking, alpine skiing and snowboarding, including but not limited to: the unevenness of the surface which contains rocks, tall and slippery grass, bumps, ruts, stumps, collisions with other trail users, trees, poles or objects, and the steepness of the terrain. I further understand that I may be in remote places without medical facilities. I am aware that hiking and ski trips in Europe may have additional risks which include the sudden onset of inclement weather, avalanches and difficult mountain terrain. Ski slopes in Europe may also have marked and unmarked dangerous obstacles and hazards (both man-made and natural). I understand that having a Penny Pitou Travel, Inc. (hereinafter referred to as "PPT") employee, guide or escort present does not lessen the amount of severity of the risks of these activities. I further understand that PPT is not responsible for my safety. I understand that any form of travel and activity during the COVID 19 pandemic creates additional risk to me (or my minor child) including the possibility of illness, disability, and death.
2. I acknowledge that no one in the PPT organization is, or claims to be, medically qualified to determine the ability of any person to engage in one of these trips. I alone am responsible for making the determination for myself (or my minor child). I hereby certify that I (or my minor child) am physically fit and have no medical conditions or allergies (known or unknown) that affect my ability to participate in these activities.
3. I hereby freely and expressly assume and accept the responsibility for any and all risks (known or unknown) of injury or death while participating in these activities or related activities, and I agree to RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND and HOLD HARMLESS Penny Pitou Travel, Inc., its owners, directors, officers, agents, employees, guides, escorts and Penny Pitou, individually, (hereinafter referred to as "Releasees") from any and all losses, damages, costs and attorney's fees resulting from any and all claims or suits for personal injury, death and/or property damage that may in any way arise out of my participation in this trip, these activities or related activities regardless of how or by whom or by what the personal injury, death and/or property damage was caused.
4. I AGREE TO RELEASE, FOREVER DISCHARGE, INDEMNIFY, DEFEND, AND HOLD HARMLESS THE RELEASEES FROM ANY AND ALL CLAIMS, SUITS, COSTS AND ATTORNEYS FEES FOR DAMAGE AND PERSONAL INJURY TO ME OR MY PROPERTY RESULTING FROM THE NEGLIGENT ACTS OR OMISSIONS OF THE RELEASEES. I UNDERSTAND THAT THE RELEASEES ARE NOT RESPONSIBLE FOR THE CONSEQUENCES OF THEIR OWN NEGLIGENCE, THAT IS, THEIR FAILURE TO USE REASONABLE CARE IN ANY WAY.
5. I understand that this Agreement shall be binding upon my heirs, executors, administrators, and assigns and shall be governed by the applicable laws of the State of New Hampshire. I also understand that if any part of this Agreement is determined to be unenforceable, all other parts shall be given full force and effect. I agree that any claims, which I may bring against the Releasees, shall be submitted to the jurisdiction of the state or federal Courts in New Hampshire and that no claims against the Releasees shall be brought in any other jurisdiction. I agree that there have been no warranties, expressed or implied, which have been made by me.
6. I agree that the guides/escorts have the right to terminate my participation in any trip, or part thereof, because of health, physical condition or unwarranted conduct and their decision shall be binding upon me.
7. I consent to PPT's use for commercial purposes, or otherwise, of any pictures (video and print), other than those taken by me, depicting me in connection with the activities of Penny Pitou Travel, Inc. or in connection with this trip.
8. I understand that permission to attend this trip, arranged by PPT is being given to the undersigned participant in exchange for the execution of this Liability Release and Covenant Not to Sue.
9. I have read the above paragraphs and fully understand them. I understand that this is a RELEASE OF LIABILITY which will legally prevent me or any other person from filing suit or making any other claims for damages in the event of personal injury, death or property damage. I freely and voluntarily enter into this Agreement. I have made no misrepresentations to PPT regarding my name, age, or medical condition.
